Notes:

- **Qualifications:** All group members must be members of ROBC, and have a genuine interest in the subject of that group as well as the time to serve. Unique member qualifications, functions and duties for each group are outlined in the Tasking Group Manual.
- **Service:** Normal service on any Tasking Group initiates on January 1 of each new year. Vacancies may be filled at any time during the year.
- **Officers:** All groups shall elect a Chairman, Vice Chairman, and Secretary. The group Chairman must have been a member of ROBC for at least one full year, unless specifically approved by Church Council. No individual may chair more than one standing committee at a time. If the group collects funds, a Treasurer shall be elected to account for those funds to the group and the Church Treasurer. *Church accounts are the only authorized depository for church related funds.*
- **Church Council:** Regular members of the Church Council shall be church staff members, directors of church program organizations, chairman of deacons, church officers, chairpersons of tasking groups, workgroup coordinators, church clerk, and church treasurer. The Pastor shall be an "Ex-Officio" member of the Church Council. The church's moderator shall serve as council moderator.
